Articles of Incorporation of

The Mediation Center of Central Florida Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To provide affordable family mediation services to central Florida residents, as well as to science fiction enthusiasts who reside within Florida. To provide free translation and mediation related services to non-English speaking Hispanic residents of Osceola County within the small claim court process at the Osceola County Courthouse. To provide free and ongoing mediation training Florida Law School Students.

The Mediation Center of Central Florida's fundraising plans will be handled by the board members, rather than professional fundraisers.

This will be done by seeking grants from appropriate state and local individuals and entities, as well as holding fundraising events on our own behalf, as well as in conjunction with other like minded state and local private organizations.

All nonprofit and fundraising activities will be simply geared towards two key functions; providing access to and reducing the cost of mediation for needy local groups as well as reducing the cost of mediation education for Florida law school students.

This will be done by:

- 1. Helping the local Non-English speaking Hispanic community to access court ordered mediation, by supplying and paying for Spanish to English translation services at the Osceola County Courthouse for weekly small claims mediation. Many Non-English Spanish speakers are turned away regularly from Florida Constitutionally protected timely access to mediation and court services.
- 2. To help reduce the cost of Family Mediation services for the local Spanish speaking community, along with both the local and greater Florida science fiction and cosplaying community.
- 3. To help provide continuing access to Mediation certification and continuing education to law students though out all of Florida.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
