We, the undersigned natural person of the age of eighteen (18) years or more, acting as Incorporators of a corporation/organization under the State of Florida Non-Profit Corporation Act, do hereby amending the following Articles of Incorporation as follow:

ARTICLE I NAME OF CORPORACION / NON-PROFIT

ARTICLE III PURPOSE OF WHICH THE CORPORATION IS ORGANIZED

- A.  - B. Upon dissolution of the Corporation/Organization or the winding up of its affairs, the assets of the Corporation/Organization shall be distributed exclusively to other Non-

Profit or Charitable organizations which would then qualify under the provisions of Section 501(c) (3) of the Internal Revenue Code and its regulations as they now exist or as they hereafter be amended.

C . The Corporation/Organization is organized pursuant of the Florida Non-Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.
