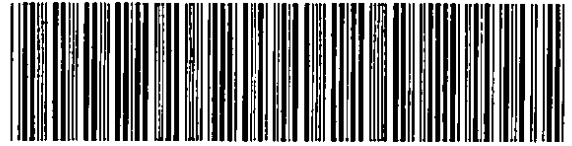

## Article VII

No part of the earnings of the Corporation shall inure to the benefit of any member, Director, Office of the Corporation or any other person, (except that the corporation may pay reasonable compensation for the services rendered to or on behalf of the corporation to make other payments and distribution in furtherance

of one or more of its purposes), and no member, director or officer of the Corporation, or any other shall be entitled to share in the distribution of any of the corporation assets on dissolution of the Corporation.

### **Article VIII**

No substantial part of the activities of the Corporation shall consist of attempting to influence legislation, by propaganda or otherwise, to an extent that would disqualify it for tax exemption under Section 501©(3) of the IRS Code The Corporation shall not participate directly or indirectly, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office. The Corporation shall not have the objectives nor engage in activities which would characterize it as an "action organization" as defined in Treasury Regulation 501@ (3)(1) © 3 as it now exists or may be hereafter amended.

### **Article IX**

Notwithstanding any other provisions of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be deducted or carried on by an organization exempt from Federal Income Tax under Section 501©(3) of the Internal Revenue Code of 1954, and Treasury Regulations thereunder as they now exist or as the many be hereafter amended, or by organization, contributions to which are deductible under Sections 170©(2) and 055(2) of such code and Treasury Regulations thereunder as they now exist or as they may be hereafter amended.

### **Article X**

Upon the dissolution of the Corporation or the winding up of its affairs, all of the assets of the Corporation shall be distributed to such organizations which then qualify as exempt organizations under Section 501©(3) of the Internal Revenue Code as amended, as the Board of Directors may direct.


