DEL B ANGEL'S, INC.**ARTICLE III
PURPOSE**

The purpose or purposes for which said Corporation is formed are:

(1) The Corporation is organized and is to be operated exclusively for charitable and educational purposes as described in Section 501(c)(3) the Internal Revenue Code of 1986 (the "Code"). In particular the corporations shall :

(a) Provide youth with program services that will allow them to recognize their self-worth and prepare them to reach their full potential in life by transitioning them from crisis to self-sufficiency;

(b) To ensure a safe and nurturing environment for adolescents by building life skills and helping them and their families find solutions to the difficulties they face; and

(c) To carry out any other activity permitted to an organization described in Section 501(c)(3) of the Code in furtherance of such purposes.

(2) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of its exempt purposes. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future United States internal revenue law, or (2) by a corporation, contributions to which are deductible under Sections 170(c)(2), 2055(a)(2) and 2522(a)(2) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future United States internal revenue law.
