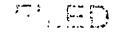

Articles of Incorporation Of

Article 1.

The name of the corporation is Solid Ground Help, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 2450 Hollywood Blvd. Ste. 401. Hollywood, FL 33020. The initial registered agent of the Corporation at such address shall be: David Smith.

Article 3.

The name and address of the incorporator is:

Article 4.

Article 5.

Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No substantial part of the activities of the corporation shall be carrying on of propaganda, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation,

contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
