ARTICLES OF INCORPORATION
OF
ASA KENT JENNINGS FOUNDATION INC.

In compliance with Chapter 617, Florida Statutes, (Not for Profit)

FIRST: The name of the corporation is:

ASA KENT JENNINGS FOUNDATION INC.

SECOND: The Principal street address is:

561 Manns Harbor Drive
Apollo Beach, Florida 33572

THIRD: The Corporation is formed for the following purposes:

A. To provide relief to refugees and other victims of totalitarian governments and oppression in South America. The foundation aims to relieve suffering, provide medical aid and equipment, provide clean water and provide safety and security services to those suffering from the lack of medical care as a result of the Coronavirus Pandemic or fleeing from oppression. The foundation will provide on site relief to those afflicted.

B. To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, or officers except as permitted under law.

C. IRS Tax Language:

Asa Kent Jennings Foundation Inc. is organized as a nonprofit IRS 501c4 tax-exempt social welfare corporation to provide relief to refugees and other victims of totalitarian governments and oppression in Latin America. The foundation aims to relieve suffering, provide clean water, educational opportunities and security to those suffering from oppression or fleeing from oppression. The foundation will award grants to regional organizations that have similar goals to support their efforts to bring stability to the region and will provide onsite relief to those afflicted.

To engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware. **This Corporation shall be a Nonprofit Corporation.**

Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more the purposes as specified in Section 501 (c)(4) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC Section 501(c)(4) or corresponding provisions of any subsequent federal tax laws.

In the event of dissolution, all of the remaining assets and property of the corporation, shall after necessary expenses thereof, be distributed to another organization exempt under section 501 (c)(4) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
