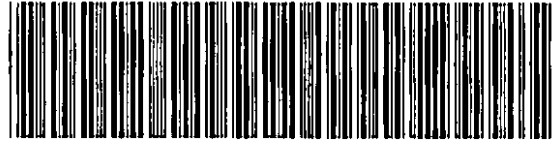

of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government,


