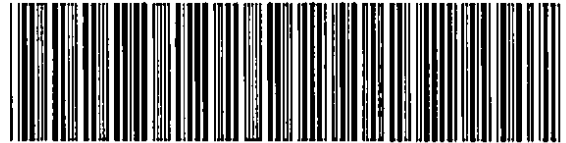

ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F. S. (Profit)

ARTICLE I – NAME

The name of the corporation shall be: **PARITY PRESS, INC.**

ARTICLE III – PURPOSE

The purpose for which the corporation is organized are:

1. To purchase, acquire, hold, own, improve develop, sell, convey, assign, release, mortgage, encumber, use, lease, hire, manage, deal, in and otherwise dispose of real property and personal property of every name and nature or any interest thereon, improved or otherwise, including stocks and securities of other corporations; to loan money; to take securities for the payment of all sums due the Company; to sell, assign, and release securities. To manufacture any personal property, to equip, furnish, improve, develop and manage and property, real or personal. invest, trade and deal in any personal property: to encumber or dispose of any personal property at any time held or owned by the Company.


