## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE MARKERS GROVE ISLE CONDOMINIUM ASSOCIATION, INC.

Pursuant to the Florida Not For Profit Corporation Act (the "Act"), THE MARKERS GROVE ISLE CONDOMINIUM ASSOCIATION, INC., a Florida not for profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

A. The Corporation desires to change its name to "VITA AT GROVE ISLE CONDOMINIUM ASSOCIATION, INC."

B. The Corporation hereby amends and restates Article 1 of its Articles of Incorporation as follows:

## ARTICLE 1 NAME AND MAILING ADDRESS

The name of the corporation shall be VITA AT GROVE ISLE CONDOMINIUM ASSOCIATION, INC., whose mailing address is Vita at Grove Isle Condominium Association, Inc., 4 Grove Isle Drive, Miami, FL 33133, or such other address as may be subsequently designated by the Board of Directors. For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles", and the Bylaws of the Association as the "Bylaws". The other terms used in these Articles shall have the same definitions and meanings as those set forth in the Declaration of Condominium for VITA AT GROVE ISLE, a Condominium ("Condominium Declaration"), unless herein provided to the contrary, or unless the context otherwise requires.

C. The Corporation hereby amends and restates Section 2.1 of its Articles of Incorporation as follows:

2.1 The Association will be the condominium association responsible for the operation of VITA AT GROVE ISLE, a Condominium (the "Condominium").

D. <u>Effective Date of Amendment</u>. This Amendment shall become effective on January 1, 2022.

E. <u>Approval of Amendment</u>. As provided in Section 12.2 of the Corporation's Articles of Incorporation, prior to the recording of the Condominium Declaration in the Public Records of the Miami-Dade County, the Articles may be amended by an instrument approved by the Board and signed by the President or Vice President and the Secretary.
