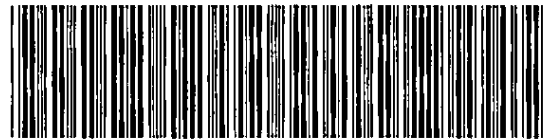

AMMEND ARTICLE III TO REFLECT THE FOLLOWING:

(1) The organization is organized exclusively for charitable, religious, educational, and scientific purposes

under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code;

(2) Generally, to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida,

or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal property;

(3) Notwithstanding and of the above statements of purpose and powers, this corporation shall not engage

in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation;

(4) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members,

trustees, officers, or other private persons, except that the corporation shall be authorized and empowered

to pay reasonable compensation for services rendered and to make payments and distributions

in furtherance of the purpose set forth in Article Three hereof;

(5) No substantial part of the activities of the corporations shall be the carrying on of propaganda,

or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in

(including publishing or distribution of statements) any political campaign on behalf of or in opposition

to any candidate for public office;

(6) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within

the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future

federal tax code, or shall be distributed to the federal government, or to a state or local government,

for a public purpose.
