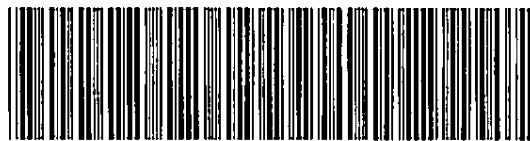

We, the undersigned, with other persons being desirous of forming a nonprofit corporation under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

Corporate Name

The name of the Corporation shall be: **BIBLE AND POP CULTURE, INC.**

ARTICLE II.

Principal Place of Business and Mailing Address of the Corporation

ARTICLE III

Corporate Purpose

Said Corporation is organized for the purposes of advancing religion, and in furtherance thereof, encouraging, soliciting, receiving and administering gifts, and producing and publishing literature and correspondence, for the purpose of stimulating discussion about the meaning and application of religion and the Bible to modern culture, including, but not limited to written materials and correspondence, websites, blogs and online magazines.

ARTICLE VIII

Effective Date; Existence; Dissolution

The effective date of these articles shall be the file date or the date of receipt by the Secretary of State. This Corporation is to exist perpetually. In the event of dissolution, the residual assets of the organization will be distributed to a nonprofit corporation, fund or foundation which is organized and operated for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code and which has established its tax-exempt status under Section 501(c)(3) of the Code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
