TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, **CP and Williams Townhomes Homeowners Association, Inc.**, the undersigned Florida non-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation.

Article I is deleted in its entirety and the following text is inserted:

**ARTICLE I
NAME**

The name of this Corporation shall be **LIVE OAK HILLS HOMEOWNERS ASSOCIATION, INC.** (the "Association").

In accordance with the Florida Not for Profit Corporation Act, this Amendment shall be effective as of the date of the filing of this Amendment with the Florida Secretary of State.

The foregoing Amendment to the Articles of Incorporation of the Corporation was proposed and adopted by the vote of all of the Directors of the Corporation pursuant to a written consent of the Directors dated March 24, 2021, such vote being sufficient for approval.
