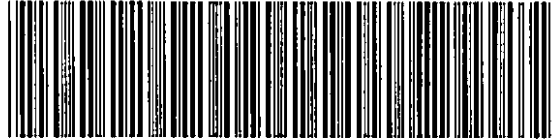

ARTICLES OF INCORPORATION

OF

LIVE2GIVE SRQ, INC.

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of this corporation shall be:

LIVE2GIVE SRQ, INC.

The principal place of business of this corporation shall be:

Sarasota, Florida 34237

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

To inspire one another, to share ideas on how to give back, to highlight businesses that are philanthropic so the consumer knows, to raise awareness for chosen charities, to be role models for our children and grandchildren and to create a culture where giving back and talking about it is the norm.

The purposes for which the corporation is organized are to collect donations for a cause or 501(c)3 organizations that offer direct services to individuals. The donations will have an intended purpose and Live2Give SRQ, Inc. will ensure the monies are given to that purpose.

For example, we heard children are turned away at lunch if their parents fall more than \$12 behind in the lunch account, we want to collect money and gift it to a school to fund these children.

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue code, or corresponding section of any future federal tax code.

ARTICLE X

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
