**ARTICLES OF INCORPORATION  
(Not for Profit)  
OF  
THE RELIEF AND AID COLLECTIVE, INC.**

**Article I – Name**

The name of the Corporation shall be The Relief and Aid Collective, Inc.

**Article II – Principal Office**

The principal place of business and mailing address of the Corporation shall be:

**Article III - Purpose**

The specific purpose for which this Corporation is organized is to address the urgent, specific needs of people who are in humanitarian crisis. More specifically, this corporation will seek to alleviate the human needs of those individuals who have been involuntarily thrown into a humanitarian crisis situation, which could include, by way of illustration, famine, climatic disaster, malnutrition, extreme poverty, social upheaval and political displacement. Among other things, the corporation will attempt to provide, either directly or in coordination with other similar-minded organizations, food, nutritional supplements, water, shelter, first aid, and other goods and services to such individuals who are subjected to a humanitarian or natural disaster. The corporation will endeavor to conduct its activities and operations both at home and abroad.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

**Article IV – Manner of Election**

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.




