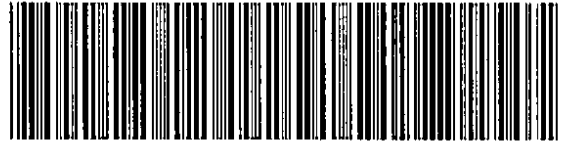

ARTICLE I
NAME

The name of this corporation shall be Wiggles & Giggles Early Intervention and Child Development Center, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal address and mailing address is 2711 Capital Medical Blvd Suite E, Tallahassee, FL 32308. The county of the registered office is Leon County.

ARTICLE III
PURPOSE

Wiggles & Giggles Early Intervention and Child Development Center, Inc. is an all-inclusive early intervention and childcare development non-profit organization specializing in caring for children with special needs. This corporation is organized pursuant to the Florida Statue Chapter 617.0202 exclusively for charitable and/or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding section in order to, at its discretion:

- (a) Advancement of education through seminars, workshops, and training sessions for the purpose of educating the individual, and family on current issues pertinent to those living with special needs and to bring awareness to the community.
- (b) Offer support and accessibility for individuals and families, through scholarships and grants, therapy services, equipment and other needs for the purpose of improving quality of life.
- (c) Any other activities deemed by the corporation's Board of Directors that will further its charitable and/or educational purposes.

This corporation is not organized, nor shall it be operated, for pecuniary gain or profit, and it does not contemplate the distribution of gains, profits, or dividends to its members and it is irrevocably dedicated to charitable and/or educational purposes. Therefore, all funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV MANNER OF ELECTIONS

The corporation will not have members. The management and affairs of the corporation shall always be under the direction of a Board of Directors, whose operations in governing the corporation and the manner in which the Directors are elected and appointed shall be defined by statute and by the corporation's bylaws. No member or Director shall have any right, title, or interest in or to any property of the corporation.

ARTICLE V DEBT OBLIGATIONS AND PERSONAL LIABILITY

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

ARTICLE VII DISSOLUTION

Upon the time of dissolution of the corporation, its assets remaining after payment of, or provisions for payment of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation that is organized and operated for charitable purposes and that has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding sections.
