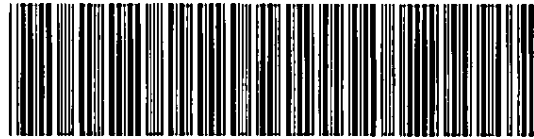

501 (c) (3) LIMITATIONS to the Articles of Incorporation of Szkoła M. Skłodowskiej-Curie, Inc.

1. **CORPORATE PURPOSES:** This corporation shall not carry on any activities not permitted to be carried on by any organization exempt from Federal taxation under section 501(a) of IRS Code as an organization described in section 501 (c) (3) of that Code.
2. **EXCLUSIVITY:** The Corporation is organized exclusively for charitable and educational purposes.
3. **NO PRIVATE PROFFIT:** The Corporation is not organized nor shall be operated for the purpose of generating profit. The Corporation shall not distribute any gains or profits to its directors or officers, or to any individual, except as reasonable compensation for services actually performed in caring out the Corporation's charitable and educational purposes. The property, assets, profits, and net income of the Corporations are irrevocably dedicated to the educational and charitable purposes no part of which shall benefit any individual.
4. **LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
5. **DISSOLUTION:** Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within meaning of Section 501 (c)3 of Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.
