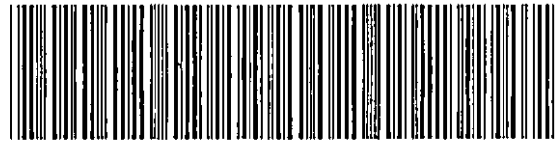

We, the undersigned, with other persons being desirous of forming a corporation for religious, charitable and philanthropic purpose, under the provisions of Chapter 617 of the Florida Statutes, the same being the incorporation of their church do agree to the following:

ARTICLE I

NAME

The name of this corporation shall be True Life Tabernacle Church, Inc.
