#### ATTACHMENT TO THE ARTICLES OF INCORPORATION OF SRB 770 RECOVERY KOLLEL INC ARTICLE III PURPOSE

This corporation is founded exclusively for religious charitable purposes with in the meaning of the Internal revenue Code section 501(c)(3): namely to establish and operate a synagogue according to the laws, heliefs and traditions of Orthodox Judaism and Chabad Chasidic tradition. This Synagogue will carry out worship services along with all day study and meditation Jewish religious texts including the Hebrew Scriptures, its Rabbinic commentaries, the Talmud, Chasidic texts and other sacred Jewish texts—this activity being considered to be the highest form of Divine Worship. It will likewise carry out religious, educational, cultural, social and all other helpful activities for the local Jewish community. These activities will include, but not be limited to: religious education classes, spiritual guidance, community outreach, inspirational events, celebrations, sacred feasts, cultural or social activities as well as all manner of helpful services to the Jewish community. Worship services and religious activities will be open to all members of the Jewish faith who wish to participate.

This synagogue will welcome members of the Jewish faith who are recovering from addictions. It will foster a contemplative community for recovering addicts who will worship and meditate daily on God's Law and on Jewish spiritual paths in the hope of finding God's presence in their lives. This corporation will be empowered to provide lodging for the members of the contemplative community as well as kosher food, religious articles and any other spiritual or material requirements needed by the contemplative community or the general congregation. The members of the contemplative community will be encouraged to progress in recovery and this corporation will be empowered to carry out any actions that are in furtherance of recovery. However it will not provide any medical, psychological or addiction based treatments or interventions. It will only accept as residents those recovering addicts who no longer require any kind of professional supervision. Rather, recovering addicts will be assisted in receiving needed treatment from licensed helping professionals located in the area.

To insure proper focus on recovery and religious devotion, the contemplative community will be differentiated by gender, being either composed entirely of males or females, as required by Orthodox Jewish religious law. Members of the contemplative community will be expected to perform acts of charity and spiritual outreach the other persons in the community suffering from addictions, insofar as this does not comprise recovery itself. This corporation will serve as a Jewish center for awareness and education concerning addiction, addiction prevention and the challenges faced by recovering addicts. It will raise awareness in the Jewish and general communities concerning ways to prevent addictions or to foster the recovery of addicts.

The synagogue will carry out its activities according to Torah-Halachic tradition contained in the Code of Jewish Law (Shulchan Aruch) by Rabbis Yosef Karo and Moshe Isserles as well as in the Code of Jewish Law by Rabbi Shneur Zalman of Liadi and the guidance of subsequent leaders of the Chabad Movement, all as understood by the synagogue's Rabbi and incorporator, Yigal Bitton. The Rabbi has been appointed according to Jewish Religious Law. He is the spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole right to determine which questions or issues should be regarded as matters of Ethics, Spirituality and Religious Law, thus requiring his

decision. This corporation will be empowered to pay salaries or wages, as well as to rent or buy personal or real property, in order to carry out its activities and provide a place of worship as well as a parsonage for Rabbi Bitton and his family.

Upon the dissolution of this corporation, the directors will --after clearing all debts and liabilities-- distribute all remaining assets to one or more organizations with similar exempt purposes recognized under section 501(c) (3) of the IRS Code.
