Article III of the Articles of Incorporation is hereby deleted in its entirety and is amended as follows:

The specific purpose for which this Corporation is organized is to foster the development of innovative solutions to systemic societal problems which impact children, and to coordinate and implement these solutions on a global scale.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
