## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WEST END AT NOCATEE HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation TO CHANGE NAME TO WEST END PHASE ONE HOMEOWNERS ASSOCIATION, INC.

These Articles of Amendment to Articles of Incorporation of West End at Nocatee Homeowners Association, Inc., were adopted on May 21, 2020 (the "Adoption Date"), by WEST END AT NOCATEE HOMEOWNERS ASSOCIATION, INC., a Florida not-forprofit corporation (the "Association") to change the Association's name from West End at Nocatee Homeowners Association, Inc. to WEST END PHASE ONE HOMEOWNERS ASSOCIATION, INC.

## **RECITALS**:

A. The Association desires to amend its Articles of Incorporation (the "Articles") as more particularly described hereafter and these Articles of Amendment have been proposed by the Association's Board of Directors and were approved on October 22, 2020 by the affirmative vote of Members holding not less than a majority of the total votes allocated to the Members of the Association.

NOW THEREFORE, the Association hereby amends the Articles as follows:

All references in the Articles to "West End at Nocatee Homeowners Association, Inc." are changed to "West End Phase One Homeowners Association, Inc."

2. All references in the Articles to "West End at Nocatee" are changed to "West End Phase One".

3. Except as specifically amended hereby, the Articles otherwise shall remain in full force and effect.
