Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: a nonprofit company that serves in education of the Fine ARTS.In many lower income areas the Arts are often forgotten. Our goal is to up lift, to educate, and entertain adults and children alike. Through Performance and Classes. We want help them discover the joy Performing Arts can bring.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
