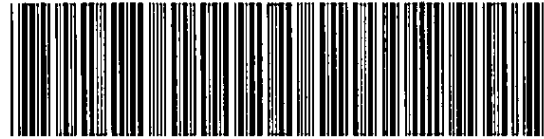

**Article III - Purpose**

The Corporation is organized is to encourage youth (age ranges 6 – 18), who often live in tough environments and who may encounter negative influences, to stay off the streets by introducing them to the world of sports on an organized level. Accordingly, the organization will encourage these youth to participate in an array of sports-related activities so that they may grow as individuals, learn teamwork, and build character.

Among other activities, the organization will organize sports camps, train youth in physical exercises, provide tutoring services as a supplement to the youth's normal education, and sponsor various athletic competitions for the benefit of such youth. Further, because building character and developing a positive moral foundation are critical to a youth's success, the organization will encourage these young people to actively participate in community service programs that will be sponsored and/or supervised by the organization.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code,

or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

#### **Article IV – Manner of Election**

The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.




