ARTICLE III: PURPOSE

H20000164399 3

Specifically, this corporation will provide religious lay ministry, aid, educational and employment services focused on English language acquisition, social adjustment, economics, and US citizenship to distressed and underprivileged immigrant populations, in the State of Florida and elsewhere. It will assist with the complex process of applying for residence permits, work permits or citizenship. It will help immigrants complete their high school equivalency diplomas. It will help skilled professionals, like doctors and nurses, validate their skills and titles in the USA, so they can acquire the certification or licensing required for work in the US. It will seek to cooperate with the Florida Department of Health, The Florida Certification Board and other State and local agencies in achieving the aforementioned goals. Likewise, this corporation will seek to cooperate with the Department of Justice in order to provide low cost representation for needy immigrants seeking to resolve their legal status.

This corporation will carry out its activities as a vehicle for the manifestation of God's purpose for humanity and serve as instrument of His redemption, according to the teachings of the Catholic Church as understood directors of this corporation, who will serve as its lay leadership. The directors in turn will seek out the guidance and instruction of the local Church authorities in all significant issues.

This corporation will conduct its activities in keeping with the letter and spirit of the IRS guidelines for a not for profit corporation. It will not distribute dividends to any of its directors or officers. That being said, it is empowered to pay for items required for the fulfillment of its mission, including but not limited to: paying for services or items provided; renting or purchasing properties or venues required for its activities; providing resources to the needy (including direct cash grants, when in the eyes of the directors, these are necessary to avoid crises); or compensating for losses incurred as part of the fulfillment of this corporation's mission. This corporation will not attempt to influence legislation in any way nor will it participate in political campaigns of any sort.

The incorporator, Yudeimy Valdes, is the founder of this corporation. She will serve as president and as a director indefinitely, until such time as
