

ARTICLES OF INCORPORATION OF

Red de Cornzones, Inc. (a Florida Not for Profit Corporation)

ARTICLE I. NAME

The name of the corporation shall be "Red de Corazones, Inc." (horeinafter referred to as the "Corporation").

ARTICLE H. PRINCIPAL OFFICE

The street address and mailing address of the principal office is 2831 South Bayshore Drive Unit 707, Miami, Florida 33133.

ARTICLE III. PURPOSE

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(e)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding provision of any future tederal tax code. Notwithstanding any other provision of these Articles, this Corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation, and the Corporation shall not early on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or the corresponding provision of any future federal tax code.

ARTICLE IV. NUMBER AND MANNER OF ELECTION OF DIRECTORS

The number and the manner in which the directors are elected or appointed shall be as stated in the Bylaws of the Corporation, provided that there shall be at least three (3) directors.

ARTICLE VI. MEMBERS

The members, if any, and qualifications of the members shall be as stated in the Bylaws of the Corporation.

ARTICLE VIL

- A. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
- B. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation. The Corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on helialf of or in opposition to any candidate for public office.
- C. Notwithstanding any other prevision of these Articles, this Corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation, and the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal hazome tax under the Code Section 501(c)(3), or the corresponding provision of any future United States internal revenue law, or (b) by a corporation, contributions to which are deductible under the Code Section 170(c)(2) or the corresponding provision of any future United States internal revenue law.

ARTICLE VIII. LIMITATION ON LIABILITY

To the fullest extent permitted by Sections 607 and 617, Florida Statutes, as now in effect or as may hereafter be amended, no director of the Corporation shall be personally hable to the Corporation for monetary damages for any breach of fiduciary duty as a director; <u>provided</u>, <u>however</u>,

such relief from liability shall not apply in any instance where such relief is inconsistent with any provision of the Code applicable to corporations described in Section 501(c)(3) of the Code.

ARTICLE IX.

INITIAL REGISTERED OFFICE AND AGENT
