ARTICLE III

The purpose or purposes for which the corporation is organized are as follows:

OSECA is the French acronym for the "Organization for Economic Security and Competitiveness of Africa. African International NGO created in Dakar in Senegal in 2004 under the name of African Organization of Competitive Intelligence ". In 2018, the AOCI becomes OSECA. On the Decision of the Board of Directors dated March 12, 2020, it was decided to create a Regional Office for the Americas (North, Central, and South America). The Regional Office for the Americas represents, the OSECA and its institutional and State partners, before local and continental public and private bodies under its jurisdiction, and defends them in the framework of the general interest. This Representation is called "OSECA – REGIONAL OFFICE FOR THE AMERICAS" Missions and objectives: 1. Economic and commercial information (offers African and American companies the latest commercial and economic information and individual advice in many areas). 2. Promotion of exchanges of service, knowledge, and resources between Businesspeople (Entrepreneurs, and professionals) 3. Linking African companies and those of the Americas with setting up meetings between entrepreneurs 4. Opportunity for Economic Operators from the two continents to present their points of view on the means of developing economic activity and increasing prosperity, of trade, industry, and services in their sector 5. Contribution to the development of investment and trade ties between the Americas and Africa 6. Establish relations of cooperation and partnerships with different structures in order to promote investment, the transcontinental economy, employment, and scientific research. 7. Defend the interests of African companies in economic debates in the Americas 8. To be the interlocutor of African companies for all their daily or strategic concerns regarding business in the Americas and vice versa. 9. Development of collective actions, through these initiatives in the organization of trade fairs, trade missions in Africa and the Americas, promoting business tourism and convention ... 10. Carry out economic studies and maps and acquire adequate structures allowing better information and supervision of African companies wishing to invest in the Americas and vice versa, as well as efficient and modern management 11. Being an AGOA Information and Training Center and Trade in MERCOSUR 12. Being a hub for African companies wishing to set up in the Americas

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for the purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
