ARTICLE IX

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this organization.

The Annual Calendar Tax year will begin January 1 and end December 31.

ARTICLE XI

In the event of dissolution, the residual assets of the organization will be irrevocably turned over to one or more religious organizations which themselves are exempt as organizations described in Sections 501 (c)(3) and 170(c)(2) of the Internal Code of 1954 or corresponding section of any prior or future law, or to the Federal, State, Local Government for exclusive public purpose. No part of the net income or assets of this organization shall ever inure to the benefit of a Director, officer or member of the corporation, or to the benefit of any private individual.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligation of the corporation, the remaining assets shall become the trust of non-profit organization.
