Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I: Name

The name of the corporation shall be: THE CHURCH OF AD MINISTRIES, INC.

Article II: Principal Office

The principal street address is 3600 McNeil Road, Apopka, Florida 32803.

The principal mailing address is 3600 McNeil Road, Apopka, Florida 32803.

Article III: Purpose

This corporation is organized to conduct Christian religious ministry with the objective of serving as an instrument in the hand of God for the proclamation of the Everlasting Gospel of the Lord Jesus Christ. To accomplish its purpose, the corporation shall:

Engage in music, preaching, teaching and such other ministries as will comfort, encourage, bless and minister to the spiritual needs of believers who are eagerly awaiting the return of the Lord Jesus Christ.

Engage in such ministry as directed by the Spirit of the Living God for the salvation of souls into the Kingdom of God by establishing various places of worship/fellowship and other venues for conducting outreach and community resource/service ministry.

Feed the hungry, clothe the naked, shelter the homeless, visit the sick, and minister to those who are in prison, and to provide such other aid to the needy as God directs and blesses it to do.

Cooperate with and submit to the ministry of the Holy Spirit whereby He leads people of all nations, kindred and tongues to accept Jesus as their personal savior, to unite with His kingdom and to allow the development of Christ-like character in them as they await the Lord's return.

Develop, maintain and engage in various forms of media ministry for the purpose of proclaiming the gospel of the Lord Jesus Christ to the world until He comes again. 11 A

Establish and maintain programs to facilitate and carry out the corporation's purpose, including but not limited to:

- 1. Food Banks.
- 2. Soup Kitchens.
- 3. Life management skills counseling.
- 4. Substance abuse counseling.
- 5. Financial benevolence as needed in vital to survive circumstances.
- 6. Thrift store ministry for clothing and personal needs assistance.
- 7. Children's and youth ministries that teach children of the Lord.
- 8. Seniors and aging members ministries.
- 9. Prison ministry for aid and comfort of prisoners and their families.

This corporation is organized for one or more of the purposes specified in Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, which shall include such purposes as those which permit/allow/encourage the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The directors and officers of the corporation shall develop and adopt a Constitution and Bylaws which shall set forth rules and procedures for the governance and conducting of the business and ministries of the corporation and, said Constitution and Bylaws shall include definitions and descriptions of various offices needed for governance and conducting of the business and ministries of the corporation, duties and qualifications for persons holding office, and they shall set forth the manner of election of office holders and directors.
