**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
SANCTUARY AT FOUNTAIN PARKE COMMUNITY ASSOCIATION, INC.
a Florida not for profit corporation**

Pursuant to the provisions of section 617.1006, Florida Statutes, Sanctuary at Fountain Parke Community Association, Inc., the undersigned Florida non-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation (the "Articles of Amendment").

1. The first paragraph of the Articles of Incorporation is deleted in its entirety and the following text inserted:

NAME

The name of this corporation shall be **SANCTUARY AT FOUNTAIN PARKE HOMEOWNERS ASSOCIATION, INC.** For convenience, the corporation shall be referred to in these Articles of Incorporation as the "Association".

2. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged and in full force and effect.

3. The foregoing Articles of Amendment were proposed and adopted by the vote of all of the Directors of the Corporation pursuant to a written consent of the Directors dated August 24, 2021, such vote being sufficient for approval.

4. The effective date and time of these Articles of Amendment shall be upon the filing of these Articles of Amendment with the Florida Department of State, Division of Corporations, and subsequent recordation of the same in the public records of Seminole County, Florida.
