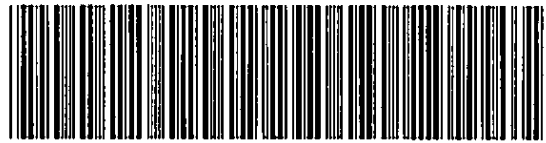

**ADDENDUM TO ARTICLES OF INCORPORATION  
OF  
RADIO WAVES OF LOVE CHURCH II, INC.**

**ARTICLE III - PURPOSE:** The purpose of which the corporation is organized is:

Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IX - PRIVATE INUREMENT:** No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

**ARTICLE X - POLITICAL ACTIVITIES:** No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE XI - DISSOLUTION:** Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE XII - SUBSIDIARY:**

- This corporation is a subsidiary of Radio Waves of Love Church I, Inc., Document Number N39357 ("Parent"). Parent is the sole member of this corporation.
- Parent has the exclusive power to amend these Articles.
- Parent has the exclusive power to voluntarily dissolve this corporation.
- Parent is not liable for the acts, debts, or liabilities of this subsidiary.
- This Parent and Subsidiary relationship is further governed as provided for in this corporation's bylaws.
