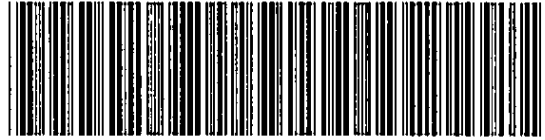


#### Article III. Purpose.
