## RESTATED ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

### ARTICLE I NAME

The name of the corporation is: The Women Rheumatology Group Corp

### ARTICLE II RESTATED ARTICLES

The text of the Restated Articles is as follows: Language to include is enclosed in separate document

The purpose of the corporation is to provide education through virtual lectures and conferences, to establish and maintain a support group for professional growth, to hold an annual dinner meeting at the American College of Rheumatology for professionals in the field, and to provide a support platform for private practices which shall include but is not limited to teaching others to manage their own practice. Further, The Women's Rheumatology Group, Corp., shall establish and maintain a fundraising program which shall include but is not limited to, personal solicitation consisting of making requests to members to donate personally via social media outlets, applying for pharmaceutical and industry educational grants, and accepting donations via its website. No part of the net earnings shall inure to the benefit of any private shareholder or individual, no substantial part of the activities shall be in carrying on propaganda or otherwise attempting to influence legislation, and The Women's Rheumatology Group, Corp., shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Women's Rheumatology Group, Inc., shall distribute its income for each taxable year at such time and in such a manner as not to subject it to tax under Internal Revenue Code § 4942. Further, it shall not engage in acts of self-dealing (as defined by Internal Revenue Code § 4941(d)), retain any excess business holding (as defined by Internal Revenue Code § 4943(c)), make any investments in such manner as to subject it to a tax under Internal Revenue Code § 4944, or make any taxable expenditures (as defined in Internal Revenue Code § 4945(d)).

Upon the dissolution of The Women's Rheumatology Group, Corp., all remaining assets shall be used exclusively for tax exempt purposes, such as charitable, religious, educational, and/or scientific purposes.


