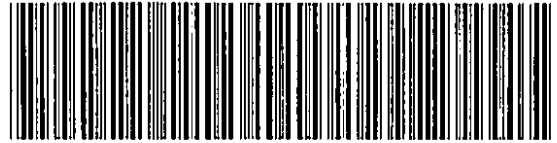

## **ARTICLES OF INCORPORATION**

### **ARTICLE I - NAME OF CORPORATION**

The name of this corporation shall be "MECHAC Accept Jesus Ministries, Inc."

### **ARTICLE II - LOCATION**

The location and mailing address shall be 14665 Apalachee St. Naples, FL 34114 in the County of Collier and State of Florida. The board may change the location of such corporation by majority vote of the board of directors.

### **ARTICLE III - PURPOSES**

The corporation is organized exclusively for charitable, educational, religious purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
