ARTICLES OF INCORPORATION**OF****TENNIS IS FOR EVERYONE, INC.
(A Not-for-Profit)**

Pursuant to Section 617.0202, Florida Statutes, the undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the corporation is Tennis Is For Everyone, Inc., a not-for-profit corporation.

**ARTICLE II
PLACE OF BUSINESS**

The principal place of business and the mailing address of the corporation is 9947 Blakeford Mill Road, Jacksonville, FL 32256, or as subsequently changed as deemed appropriate by the Board of Directors.

**ARTICLE III
PURPOSE**

The corporation is organized exclusively for charitable, educational, civic, cultural and other exempt purposes.

**ARTICLE IV
DISTRIBUTIONS; SELF-DEALING**

The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any further federal tax code. The corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation will not make any taxable expenditures as defined in section 4945 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V BOARD OF DIRECTORS

The affairs of the corporation will be managed by a Board of Directors. The number of directors that will constitute the Board of Directors of the corporation is three (3). The number of directors may be increased or decreased from time to time, in the manner provided in the bylaws. ARTICLE VII DISSOLUTION

Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for educational and charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

ARTICLE VIII REGISTERED AGENT

Pursuant to Section 617.0501, Florida Statutes, the corporation has designated Carson Phillips as the initial Registered Agent of the corporation and the street address of the initial Registered Agent is 9947 Blakeford Mill Road, Jacksonville, FL 32256.

ARTICLE IX BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested to the Board of Directors, as provided in the bylaws of the corporation.


