ARTICLES OF INCORPORATION OF S2 - FUNDACIÓN SEMBRANDO SEMILLAS, INC., A FLORIDA NONPROFIT CORPORATION

ARTICLE I NAME

The name of this corporation is:

S2 - Fundación Sembrando Semillas, Inc.

ARTICLE II STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Corporations Not For Profit law set forth in Chapter 617 of the Florida Statutes.

ARTICLE III GENERAL AND SPECIFIC PURPOSES

- (a) The specific, primary and sole purpose for which this corporation is formed is to operate for charitable purposes. This organization is primarily dedicated to developing medical education programs to enhance healthcare in underserved regions around the world.
- (b) The general purpose for which this corporation is formed is to operate exclusively for such educational and charitable purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or corresponding provisions of any subsequent Federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under the Code. Notwithstanding any other provisions of these Articles, this corporation will not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Code or the corresponding provision of any future United States Internal Revenue Code; or, (b) a

corporation, contributions to which are deductible under Section 170(c)(2) of the Code or any other corresponding provisions of any future United States Internal Revenue Code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE IV TERM

This corporation shall have a perpetual existence.

ARTICLE V QUALIFICATION OF MEMBERS AND THE MANNER OF THEIR ADMISSION

The corporation shall have a membership distinct from the board of trustees. There shall be three (3) members of the corporation, and they shall consist of the trustees of the foundation.

Only the trustees of the foundation shall qualify as a member of the foundation. A majority vote of the trustees shall determine the manner of admission of members. When a trustee leaves the foundation for any reason, the remaining trustees by majority vote shall elect a successor trustee and such successor trustee shall qualify for membership in the corporation.

ARTICLE VI INCORPORATOR

The name and address of the incorporator of this corporation is as follows: STEVEN J. SCHERMER, 401 E. Las Olas Blvd., Suite 1400, Fort Lauderdale, FL 33301.

ARTICLE VII LOCATION OF PRINCIPAL OFFICE

The principal office of this corporation is located at 401 E. Las Olas Blvd., Suite 1400, Fort Lauderdale, FL 33301.

ARTICLE VIII <u>IDENTIFICATION AND ADDRESS OF REGISTERED AGENT</u>

The name and address of this corporation's registered agent is STEVEN J. SCHERMER, 401 E. Las Olas Blvd., Suite 1400, Fort Lauderdale, FL 33301. This shall also be the corporation's registered office.

ARTICLE IX MANAGEMENT OF CORPORATE AFFAIRS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of trustees. The number of trustees of the corporation shall be three (3); provided, however, that such number may be changed by a by-law duly adopted by the members.

The trustees shall hold office until his or her successor has been elected and qualified as set forth in the by-laws of this corporation or until his or her earlier resignation, removal from office or death.

ARTICLE X BY-LAWS

Subject to the limitations contained in the by-laws, and any limitations set forth in the Corporation Not For Profit law of Florida, concerning corporate action that must be authorized or approved by the members of the corporation, by-laws of this corporation may be made, altered, rescinded, added to, or new by-laws may be adopted, by a resolution of the board of trustees, adopted by a majority.

ARTICLE XI DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, trustee, officer, or member thereof, or to the benefit of any private individual.

ARTICLE XII DISTRIBUTION OF ASSETS

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Code, or corresponding provisions of any subsequent federal tax laws.

ARTICLE XIII AMENDMENT OF ARTICLES

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the board of trustees and presented to a quorum of members for their vote. Amendments may be adopted by the vote of two-thirds (2/3) of a quorum of members of the corporation.

I, the undersigned, being the sole incorporator of this corporation, and including the person herein named as the incorporator of this corporation, for the purpose of forming this nonprofit charitable corporation under the laws of Florida have executed these Articles of Incorporation on July 2, 2020.
