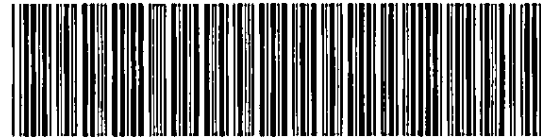

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

We will raffle off prizes on a daily basis and a portion of the proceeds will be used to purchase materials and pay for labor to donate sanitary and safety needs such as bathrooms and kitchens in homes within Sarasota and Manatee County. Raising money to do work for those who would otherwise not be able to get the work done, would help improve the value of their home and overall community. ARTICLE X



Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.


