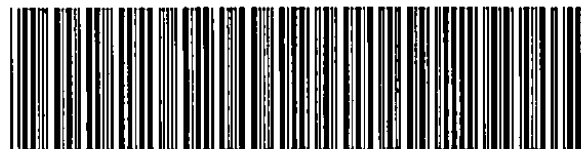

# **Dissolution Clause Statement**

Articles of Incorporation

## **PROTECT ME, Inc.**

Article of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**First:** The name of the Corporation shall be PROTECT ME, Inc.

**Second:** The place in this State where the principal office of the Corporation is to be located at 1721 Inlet Street in the City of Quincy, FL, 3235, Gadsden County.

**Third:** Said corporation is organized exclusively for the purpose of providing financial support and/or financial assistance (i.e. payments of rent/mortgage, utilities bills, emergency food supplies and clothing) to disadvantaged, underprivileged and impoverished individuals, families and our Veterans in the United States and other countries. This will include connecting them to supportive services that leads to health, wellness and economic stability for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Fourth:** The name and address of the person who are the initial trustees of the corporation are as follows:

**Fifth:** The property of this Corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the corporation shall ever inure to the benefit of any director, trustee, member or officer of this corporation, or to any private person.

**Sixth:** Upon the dissolution or winding up of the corporation, any assets remaining after payment of, or provision for payment of, all debts and liabilities shall be distributed to a governmental entity described in Section 170(b)(1) (A)(vi) of the Internal Revenue Code, or to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, and which is qualified to receive "qualified conservation contributions" within the meaning of Section 170(h) of said Code, or the corresponding provisions of any future statute of the United States.

In the event of a liquidation of this corporation, all corporate assets shall be disposed of in such a manner as may be directed by decree of the superior court for the county in which the corporation has its principal office, on petition therefore by the Attorney General or by any person concerned in the dissolution, in a proceeding to which the Attorney General is a party.
