Articles of Incorporation

PROTECT ME, Inc.

Article of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Corporation shall be PROTECT ME, Inc.

Second: The place in this State where the principal office of the Corporation is to be located at 1721 Inlet Street in the City of Quincy, FL, 3235, Gadsden County.

Third: Said corporation is organized exclusively for the purpose of providing financial support and/or financial assistance (i.e. payments of rent/mortgage, utilities bills, emergency food supplies and clothing) to disadvantaged, underprivileged and impoverished individuals, families and our Veterans in the United States and other countries. This will include connecting them to supportive services that leads to health, wellness and economic stability for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
