Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To assist schools - Schools do not go to airports anymore and with their S T E M programs our program "Bring the Airport Field Trip to Your School. We will bring a folding wing airplane to schools and have students learn about aviation and sit in a real flying airplane. @ end of each school event 2 students will have a flight in airplane
