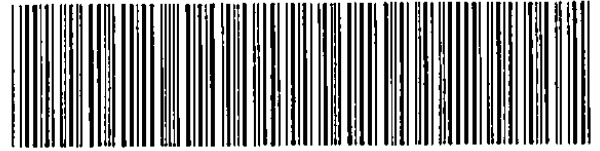

**ARTICLES OF INCORPORATION
OF

I

The Name of the corporation shall be **HIDDEN OAKS TALLAHASSEE HOMEOWNERS ASSOCIATION, INC.**

II

The duration of the corporation shall be perpetual.

III

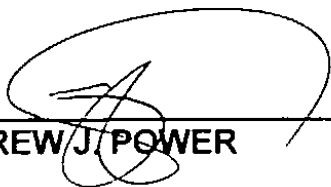
