ARTICLES OF INCORPORATION

ARTICLE I NAME

1.01 Name

The name of this corporation shall be GiveHeed, Inc. The business of the corporation may conducted as GiveHeed, giveheed, or The Vagabond Group.

ARTICLE II DURATION

2.01 Duration

The period of duration of the corporation is perpetual.

ARTICLE III <u>PURPOSE</u>

3.01 Purpose

GiveHeed, Inc. is a non-profit corporation and shall operate exclusively for charitable purpose within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the correspond section of any future Federal tax code. GiveHeed, Inc. purpose is to provide aid, relief, opportunity to members of the public, specifically those who are homeless, otherwise classified "Vagabonds", and who may be aimlessly wandering as a direct result of financial hardship, nat

disaster, or misfortune. Our mission is to eradicate and improve homelessness on a local and glol level by providing innovative and resourceful solutions that yield temporary and long-term resu

3.02 Non-Profit

GiveHeed. Inc. is designated as a non-profit corporation.

ARTICLE IV NON-PROFIT NATURE

4.01 Non-profit Nature

GiveHeed, Inc. is organized exclusively for charitable and educational purposes including, such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any fut federal tax code. No part of the net earnings of GiveHeed, Inc. shall inure to the benefit of, or distributable to its members, trustees, officers, or other private persons, except that the corporat shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in the purpose cla hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any of activities not permitted to be carried on (a) by any organization exempt from federal income under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future fed-tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) of the Internal Revenue Code, or corresponding section of any future federal tax code.

GiveHeed, Inc. is not organized and shall not be operated for the private gain of any person, property of the corporation is irrevocably dedicated to its educational and charitable purposes, part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, of distributed to any individual. The corporation may, however, pay reasonable compensation services rendered, and make other payments and distributions consistent with these Articles.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligation GiveHeed. Inc. of any nature whatsoever, nor shall any of the property or assets of the officer directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of GiveHeed, Inc., any assets lawfully available for distributed to one (1) or more qualifying organizations described in Section 501(c)(1) the Internal Revenue Code of 1986 (or described in any corresponding provision of any succe

statute) which organization or organizations have a charitable purpose which, at least general includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of GiveHeed, Inc. hereunder shall be selected by a discretion of a majority of the managing body of GiveHeed, Inc. and if its members cannot agree, then the recipient organization shall be selected pursuant to a verified petition in equity find a court of proper jurisdiction against GiveHeed, Inc. by one (1) or more of its managing be which verified petition shall contain such statements as reasonably indicate the applicability of t section. The court upon a finding that this section is applicable shall select the qualify organization or organizations to receive the assets to be distributed, giving preference if practica to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualify organization known to it which has a charitable purpose, which, at least generally, include purpose similar to this corporation, then the court shall direct the distribution of its assets lawful available for distribution to the Treasurer of the State of Florida to be added to the general fun-

4.04 Prohibited Distributions

No part of the net earnings or properties of this corporation, on dissolution or otherwise, shall into the benefit of, or be distributable to, its members, directors, officers or other private persoindividual, except that the corporation shall be authorized and empowered to pay reasonate compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in Article III, Section 3.01.

4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda otherwise attempting to influence legislation, and the corporation shall not participate in intervene (including the publishing or distribution of statements) in any political campaign behalf of or in opposition to any candidate for public office.

4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on activities not permitted to be carried on (I) by a corporation exempt from federal income tax a organization described by Section 501(c)(3) of the Internal Revenue Code, or the correspondential section of any future federal tax code, or (II) by a corporation, contributions to which are deduct under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
