Sumter Landing Bicycle Club, Inc.

ARTICLE I NAME

The name of the corporation shall be: Sumter Landing Bicycle Club, Incorporated

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which this corporation is organized is to: Promote bicycling for recreation, health, and pleasure, and as a means of transportation for commuting and shopping; Promote bicycle touring and arrange bicycle rides to fit varying skills; Sponsor bicycle events such as touring rides and group activities; Encourage and work for bicycling education and promote safe bicycling; Work to encourage the planning and development of bikeways within The Villages and the surrounding area; and Provide social events for the membership, such as dinner dances.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed: Twelve directors are elected by the membership, and the past president is an ex-officio, non-voting director. Four director positions are elected each year and the directors serve 3 year terms. Nominations for directors are presented by the Nominating Committee at the October membership meeting. Nominations for directors can also be made by club members at that meeting from the floor. A member nominated from the floor must be present to accept the nomination. The annual election of directors takes place at the November membership business meeting, and elected directors take office on January 1.

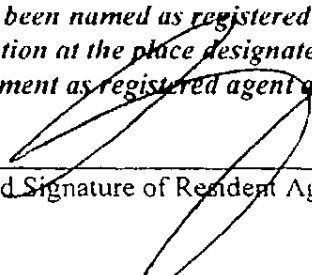

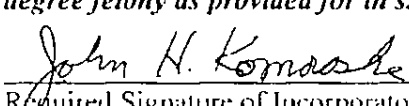
