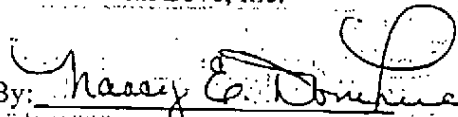
1. The name of the Corporation is: Lessons With Love, Inc., filed under File No: N20000009269.

EXHIBIT ALESSONS WITH LOVE, INC.PLAN OF LIQUIDATION

1. This Corporation shall be dissolved and liquidated effective at 11:59 p.m. on September 1, 2024 ("Effective Date").
2. Upon the adoption of this Plan of Liquidation by the members of the board of directors the proper officers of the Corporation shall execute and file Articles of Dissolution with the Florida Department of State.
3. All debts, liabilities and obligations of this Corporation shall be paid and discharged, or adequate provision made for payment or satisfaction thereof.
4. On or before the Effective Date, the Corporation shall transfer all of its remaining assets, if any, to RiseUp Malawi, Inc. (EIN: 82-4320118) (the "recipient"), which is tax-exempt within the meaning of Section 501(c) (3) of the Internal Revenue Code, all in furtherance of the Corporation's exempt purpose.
5. The amount of \$5,000 shall be retained and held by the Corporation in its accounts for a period not to exceed ninety (90) days for the payment of any unknown liabilities. Upon expiration of said period, any remaining corporate funds shall be distributed to RiseUp Malawi, Inc. or one or more exempt organizations within the meaning of Section 501(c) (3) of the Internal Revenue Code.
6. The proper officers of this Corporation shall take all actions necessary to distribute the foregoing assets and to effect the dissolution and liquidation of the Corporation.

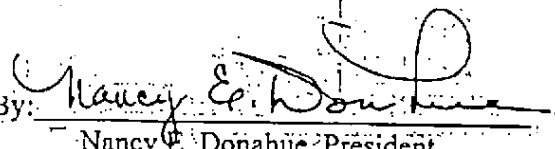
