ARTICLES OF INCORPORATION
THE SELENE & EASTERLY CONDOMINIUM ASSOCIATION, INC.

The undersigned incorporator, forms this corporation not for profit pursuant to the laws of the State of Florida, and adopts the following articles of Incorporation:

ARTICLE 1. NAME. The name of this corporation is THE SELENE & EASTERLY CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association," these articles of incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

ARTICLE 2. TERM OF EXISTENCE. The Association shall have perpetual existence.

ARTICLE 3. PURPOSE. This Association is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act") for the operation of a condominium located in Walton County, Florida and known as The Selene & Easterly, a Condominium (the "Condominium"), created pursuant to the Declaration of Condominium (the "Declaration").

ARTICLE 4. MEMBERS. The qualification of members shall be contained in the Bylaws.

ARTICLE 5. INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT.
