ARTICLES OF INCORPORATION

<u>OF</u>

TRUTH WORSHIP CENTER INTERNATIONAL, INC.

(A FLORIDA CORPORATION NOT-FOR-PROFIT)

Pursuant to Section 617.1007, Florida Statutes. (Not for Protit) the undersigned, as all of the Directors of **TRUTH WORSHIP CENTER INTERNATIONAL, INC.,** a Florida corporation not for profit (the "Corporation"), a corporation organized and existing under the Florida Not For Profit Corporation Act, does hereby certify that:

ARTICLE I

<u>NAME</u>

The name of the Corporation is TRUTH WORSHIP CENTER INTERNATIONAL, INC.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of the Corporation shall be 6947 Bitterbush Pl, Boynton Beach, Florida 33472.

ARTICLE IV

PURPOSE

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

ARTICLE V

NO MEMBERS

The Corporation shall not have Members.

ARTICLE VI

NO DISTRIBUTION OF PROFITS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

PROHIBITION AGAINST POLITICAL ACTIVITIES

No substantial part of the activities of the Corporation shall be devoted to the promulgation of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under §501(a) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under §170(c)(2) of the Internal Revenue Code of 1986, as amended or the corresponding section of any future federal tax code.

ARTICLE VIII

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Corporation is 7931 Woodsmuir Dr., Palm Beach Gardens, Florida 33412. The name of the initial registered agent of the Corporation at that address is Juanita Johnson.

ARTICLE IX

INITIAL BOARD OF DIRECTORS

The initial officers of the Corporation shall be appointed by the President of the corporation. Additional officers shall be appointed and confirmed via a majority vote during quarterly meetings.
