

FIRST AMENDMENT to ARTICLES OF INCORPORATION of ACADEMIC MEDICAL GROUP, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, Academic Medical Group, Inc., a Florida not-for-profit corporation, hereby adopts the following amendments to its Articles of Incorporation:

- 1. <u>Name of Corporation</u>. The name of the Corporation is Academic Medical Group, Inc. (the "Corporation").
- 2. Text of Amendments,
 - A. Article VI is deleted in its entirety and replaced with the following:

ARTICLE VI Directors

The number of Directors of the Corporation (the "Directors") shall be specified in or fixed in accordance with the bylaws. The number may be increased or decreased from time to time pursuant to the bylaws and the election or appointment shall be as specified in the bylaws, provided that the Corporation shall always have at least six (6) Directors.

- 3. Date of Adoption. The Amendment was adopted on January 6, 2021.
- 4. Manner of Adoption. The Amendment was adopted at a meeting of the Board of Directors on January 6, 2021. The number of votes cast in favor of the Amendment was sufficient for approval.
