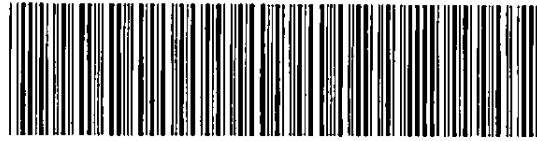

ARTICLE III - PURPOSE

The purpose is to establish a church that molds fully devoted followers of Jesus Christ. Witnessing to the lives of the lost and destitute in need of a personal Savior of grace and truth through Jesus Christ, our Lord. To nurture and grow a body of Christ believer's to become disciples for Him. This corporation is organized for charitable and religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt under Section 501(C)3 of the

Internal Revenue Code, or corresponding section of any future federal tax code. Lastly, to transact any and all lawful business for which corporations may be incorporated under the Florida Not-For-Profit Corporation Act.

Section B - No part of the net earnings of the organization shall inure to the benefit of or be distributed to its directors, trustees, officers, or any other private individual (except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make distributions in furtherance of the set forth. No substantial part of the activities shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section of any federal tax code, or (b) by organization contributions to which are deductible under section 170(c)2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section C - Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal code, or shall be distributed to the local, state or federal government for public purposes. Any such assets not disposed of, shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

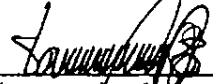
