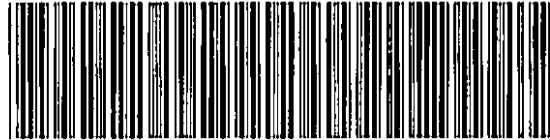

Amend - Article IV, *The manner in which directors are elected or appointed is:*



Upon dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations, and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively but in its sole discretion to another nonprofit organization(s) which are tax exempt qualified under section 501(c)(3) of the Internal Revenue Code.
