Notice is hereby given that the undersigned incorporators, all being of full age, have associated themselves together for the purpose of forming a corporation not for profit, without capital stock, under the provisions of Chapters 607 and 617, Florida

Statutes and we do hereby accept all of the rights, privileges, benefits and obligations conferred and imposed by such law, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

### ARTICLE I - NAME

The name of the Corporation is TEMPLE DE LA PROMESSE DE DIEU, INC

(TEMPLE OF PROMISE OF GOD, INC).

#### ARTICLE II - CORPORATE PURPOSE

The object and purpose of the Corporation is the creation of a congregation of Christians entitled to protection in the free use of their religion by the constitution and the laws of this State.

The object and purpose of the Corporation shall also be to raise, receive and maintain a fund or funds of real property or personal property, or both, and to distribute and administer the fund or funds, including any income or interest generated therefrom, exclusively for charitable, religious or educational purposes.

The purpose shall include, but not be limited to, any other lawful activity engaged in by a corporation not for profit permitted by the laws of the State of Floridarand; the United States of America.

#### ARTICLE III - MEMBERSHIP

Section 1: Eligibility. Any person shall be eligible for membership in this

Corporation upon application to and approval as provided in Bylaws of the Corporation.

Section 2: Application for Membership. Any applicant meeting the qualifications set forth above and desiring to become a member of the Corporation shall make application on a form supplied by the Corporation and accompanied by such membership fees and dues as the Board of Directors may from time to time determine.
