Amendment IX.

Upon the dissolution of HoodAlum Inc., the board of directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets to one or more exempt organization with the meaning of section 501 ©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organization or organizations, as a Court Shall determine, which are organized and operated exclusively for such purposes.

Article: X

The said organization is organized exclusively for charitable, religious, educational, and scientific purposes including, such purposes, the making of distributions to organization that qualify as exempt organizations under section 501©(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
