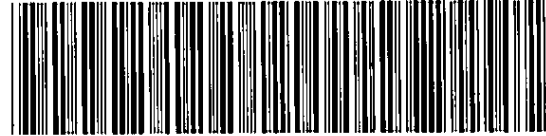

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, the Articles of Incorporation of The Arthur Lee McDuffie Center For Racial Justice, Inc., a Florida for not-for-profit corporation, are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is The Arthur Lee McDuffie Center For Racial Justice, Inc.

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the Article I thereof as it now exists and replacing it in its entirety to read as follows:


"ARTICLE I Name
